# WASHINGTON TOWNSHIP SUPERVISORS MEETING -January 16, 2017 - 7:00 pm

The regular meeting of the Board of Supervisors of Washington Township was called to order by Chairman McCleaf. The meeting was opened with the Pledge of Allegiance.

**PRESENT:** Supervisors McCleaf, Conrad, Gladhill, McCracken and Reichard. Also present were Manager Mike Christopher, Assistant Manager Jeffrey Geesaman, Secretary Karen Hargrave, Township Planner Clint Rock, Assistant Secretary Sarah Ginn, Chief Keller, and 23 citizens.

## FROM THE FLOOR:

## 1. Special Presentation

Supervisor McCleaf presented Fara Biesecker with a resolution highlighting the community service her husband Robert did for Washington Township. Robert passed away on December 28, 2016. Also present were Fara and Robert's sons, Levi and Nathan.

## 2. Ronnie Martin to address the Board

Ronnie Martin spoke on his concerns regarding the impact fees. He feels that the impact fees are too high and several potential commercial businesses have been lost over the excessive fees.

**APPROVAL OF THE AGENDA:** On a Conrad/Reichard motion, the Board of Supervisors approved the agenda as presented, vote was unanimous.

# 1. 11-14 Susquehanna Trust-Withdrawal Letter

Clint Rock, Township Planner, advised the Board of Supervisors that a letter dated January 1, 2017 was received from R. Lee Royer requesting the withdrawal of plan 11-14 because it has been renamed under the F&M Trust Antietam Humane Society. On a Conrad/Gladhill motion, the Board of Supervisors approved the withdrawal of plot plan 11-14, vote was unanimous.

# 2. Plan 8-16 Antietam Humane Society- 1 lot final

Clint Rock, Township Planner, advised the Board of Supervisors this plan was a final plan. This plan had a name change from Susquehanna Trust to Farmers & Merchant Trust. The Franklin County Planning Commission had no comments. WTMA sent a letter dated January 12, 2017 giving final approval to the plan. The Township Planning Commission recommended approval on September 12, 2016. On a Conrad/Gladhill motion, the Board of Supervisors approved plot plan 8-16 Antietam Humane Society, 1 lot final, vote was unanimous.

# 3. Plan 11-16 Tier One Properties- Time Extension Request to 01-02-2018

Clint Rock, Township Planner, advised the Board of Supervisors that a letter dated January 1, 2017 was received from R. Lee Royer requesting a time extension for Tier One Properties to January 2, 2018. On a Reichard/Conrad motion, the Board of Supervisors approved the time extension for Tier One Properties from January 1, 2017 to January 1, 2018, vote was unanimous.

# 1. Washco Avalon Townhomes Tax Appeal

The Solicitor presented information to the Board of Supervisors concerning an assessment appeal for Washco Avalon Townhomes, LLC versus the Franklin County Board of Assessment Appeals. On a Conrad/Gladhill motion, the Board of Supervisors voted to not actively participate in the tax appeal of Washco Avalon Townhomes, vote was unanimous.

# 2. Executive Session-Legal and Real Estate Matters

On a Conrad/Gladhill motion, the Board of Supervisors entered into executive session at approximately 7:29 pm, vote was unanimous.

On a Conrad/Reichard motion, the Board of Supervisors came out of executive session at approximately 8:12 pm, vote was unanimous.
