We ask that this be done in an expeditious manner for the following reasons:

- Buena Vista Drive and Monta Vista Drive have seen a dramatic increase in traffic since Amsterdam Road was detoured into our development.
- Speeding on Buena Vista and Monta Vista is an ongoing issue.
- Drivers pay little or no heed to the stop sign at the corner of Buena Vista and Monta Vista.
- Supervisors recently approved improvements to a failing box culvert on Wyndham Avenue off the Fort Ritchie Road in Blue Ridge Summit. We feel our neighborhood deserves an immediate resolution on Amsterdam Road.
