The Manager tried to explain that at their earlier request we regraded the swale between their drives but the end of their drive is the water swale and the last rain we had was 5.5 inches in several hours, which is an unusual event around here. It was explained that the regrading only happened 2 days before the hard rain and grass was not yet established which caused the "muddy water" condition. They didn't understand so it was decided that the next time it rains, if we are available, Staff will meet them and review the problem.
