From the Supervisors: Budget 2015: The 2015 Preliminary Budget was approved by the Supervisors at their November 17, 2014 meeting. A copy of the Township's proposed budget is available in the Township office for review during regular work hours and on the Township's website at www.washtwp-franklin.org.

This year's preliminary budget keeps the property tax at 6.4 mils for the third year in a row. Other taxes remain the same as year 2014 as well.

The operating funds (general fund and state fund) are up 1.17% or \$97,000 more than last year and provide funding for the continuation of police, fire, public works services, snow removal and office support at basically the same levels compared to year 2014. Capital projects for the year include completing the Calimer Drive sewer project, building the bike park at Pine Hill and purchasing additional Civil War Battlefield land in Blue Ridge Summit.

The overall preliminary budget is up \$491,155 over the 2014 budget for a total of \$12,567,342.00. The primary reasons for the increase are higher pension funding carryover and grant funding.

Comments from the public will be taken by the Supervisors at their meeting on December 1, 2014, beginning at 7:00 p.m. Final adoption of the 2015 budget is scheduled for the December 15, 2014 meeting. Washington Township Boulevard Construction Update – Through the great statesmanship of Senator Richard Alloway, the Township has been notified that our grant application for \$2,000,000 to construct the Boulevard from Old Forge Road to Rt. 997 has been approved.

Depending on the rules and requirements of the grant, the Township is hoping to start construction this summer and complete as much of the Boulevard as possible before next fall. As more information becomes available the township will keep you posted in this column and on our website.

Tax Collector News: Deadlines, deadlines... the last day for paying the 2014 Franklin County Real Estate and the 2014-15 Waynesboro Area School District Real Estate tax bills is December 31, 2014. After that time both taxes will have to be paid to Franklin County Tax Claim. The last day for paying the 2014-15 Per Capita/Occupation tax bills is December 31, 2014.
