Supervisors Replacement Process: The remaining 4 Township Supervisors have 30 days from the date of a vacancy on the Board to fill that position. If you are interested in being considered for the vacant seat you will need to complete an application and submit it to the township office by February 9, 2015 at 4:30PM. Interviews will be scheduled at the Workshop meeting on February 11, 2015 beginning at 7:15 PM. Interviews are open to the public and press.

The requirements to be a township supervisor are that you are a registered voter and have lived in the township for a least one year.

Township Supervisors have 4 evening meetings each month that they are expected to attend plus additional meetings at the County and with State/Federal officials.
