## **WASHINGTON TOWNSHIP NEWSLETTER**

## December 2015

**From the Supervisors**: In year 2013 we raised taxes 2 mills to carry our expected budget expenditure increase for at least 5 years. Unfortunately, our income (revenue) is unable to keep up with the cost (expense) and this has taken our General Fund to a negative dollar amount for 2015.

Previously, we have not refilled vacant positions such as office and public works staff. Recently, we laid off the entire Recycling Center staff and revamped our recycling program. This will allow us to continue to provide recycling services at a cost saving to our General Fund. These previous cuts allowed us to maintain the Police Department without any cuts until this year. However, we still faced a \$317,600 or approximately 2.3 mills deficit. With cuts in all the other departments completed, the Police Department was the only Department where we could cut to avoid a property tax increase. So we have to either cut the Police Department's budget or raise your taxes to keep the same size department.

With the approval of the Preliminary Budget on November 16, 2015 we have decided to cut the Police Department's budget and the number of full time officers from 14 to 10 instead of raising your property tax.

We believe the 10 officers remaining will be able to provide excellent Police services for our residents or we would not have made these cuts.

Please keep in mind that Washington Township is the only Township in Franklin County that provides local police services for its residents. The other 14 townships, some much larger than ours, are provided police protection by the PA State Police with no local property taxes being provided for this service.

A copy of our Preliminary Budget has been posted on our web page at <a href="www.washtwp-franklin.org">www.washtwp-franklin.org</a> for our residents to review.

At our next regular meeting on December 7, 2015 we will take comments from our residents on the Preliminary Budget. This meeting starts at 7:00 PM. We will adopt the final budget on December 21, 2015.

**Tax Collector News:** Deadlines, deadlines... the last day for paying the 2015 Franklin County Real Estate and the 2015-16 Waynesboro Area School District Real Estate tax bills is December 31, 2015. After that time both taxes will have to be paid to Franklin County Tax Claim. The last day for paying the 2015-16 Per Capita/Occupation tax bills is December 31, 2015.
