**Washington Township Boulevard Update**: Work has begun on the section of Washington Township Boulevard from Gehr Road to Tomstown Road. As weather permits work will be done on this section of the Boulevard to construct the storm water system and subbase as well as upgrading the intersection at Gehr Road. Work will continue throughout the summer. This is a continuation of the work that allowed the portion of the Boulevard from Old Forge Road to Gehr Road to be complete from the Multi Modal Grant that was received from PennDOT in 2015. This portion of the project will not be open to any traffic during construction.
