ORDINANCE NO. 260

AN ORDINANCE OF THE BOARD OF SUPERVISORS  
OF THE TOWNSHIP OF WASHINGTON, FRANKLIN  
COUNTY, PENNSYLVANIA PROHIBITING PARKING  
ALONG NORTH WELTY ROAD

**WHEREAS**, section 1527 of the Second Class Township Code as amended, (53 P.S. 66527) authorizes the Board of Supervisors of Second Class Townships to adopt ordinances to secure the safety of persons of property within the Townships: and

**WHEREAS**, section 2328 of the Second Class Township Code as amended, (53 P.S. 67328) authorizes the Board of Supervisors of Second Class Townships to adopt ordinances regulating parking and further authorizes the imposition of penalties for violations of the parking regulations: and

**WHEREAS**, the Pennsylvania Vehicle Code authorizes local authorities on streets or highways within their physical boundaries to regulate or prohibit stopping, standing or parking (75 Pa. C.S.A. §6109); and

**WHEREAS**, the Vehicle Code provides that local authorities may exercise the powers granted in the code only by duly enacted ordinances of their governing bodies (75 Pa. C.S.A. §6102-b); and

**WHEREAS**, a traffic study has been prepared for North Welty Road; and

**WHEREAS**, said study indicated that the traffic regulations as set forth in this ordinance should be enacted.

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED** by the Board of Supervisors of Washington Township, Franklin County, Pennsylvania, pursuant to the authority as described above and in accordance with the Traffic Study in Exhibit A attached hereto and incorporated herein by reference, that the Code of The Township of Washington shall be amended in the following manner.

**SECTION 1.** A new Article III shall be added to chapter 333 of the Code of The Township of Washington entitled: "No Parking".

**SECTION 2.** A New Section 333-9 shall be added to the Code of The Township Washington and said Section shall read as follows:

**333-9 – Parking prohibited at all times in certain locations.**

**Parking shall be prohibited at all times in the following locations:**

<u>Street</u>	<u>Side</u>	<u>Location</u>
North Welty Road	Both sides	From PA Route 16 to the round-about at the intersection of North Welty Road and Washington Township Boulevard.

**SECTION 3.** The Penalties for violating this ordinance shall be set forth in the Pennsylvania Vehicle Code, as amended.

**SECTION 4.** The provisions of this ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect the remaining provisions of this ordinance.

**SECTION 5.** All other ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 6.** This ordinance shall take effect five (5) days after its enactment.
