ORDINANCE NO. 258

**AN ORDINANCE SETTING THE SPEED LIMITS ON
WASHINGTON TOWNSHIP BOULEVARD T-429 AND
ESTABLISHING THE PLACEMENT OF STOP SIGNS
WITH ALL INTERSECTING STREETS.**

WHEREAS, an Ordinance establishing the speed limit on Washington Township Boulevard has not been ordained; and

WHEREAS, the Washington Township Board of Supervisors, in order to advance the welfare and safety of the residents of the Township and such other persons who use Washington Township Boulevard, deem it necessary to set speed limits on Washington Township Boulevard; and

WHEREAS, the Vehicle Code of Pennsylvania, Section 6109 provides for the establishing of speed limits on roads; and

WHEREAS, the Vehicle Code of Pennsylvania, Section 6109 provides for the placement of stop signs at intersecting streets; and

WHEREAS, the Board of Supervisors, retained the services of Grove Miller Engineering to complete a traffic study of Washington Township Boulevard for both the speed limit study and the placement of stop signs; and

WHEREAS, the completed traffic study concluded that the speed limit on Washington Township Boulevard should be both 25 MPH and 35 MPH and that stop signs should be placed at intersecting streets.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the Board of Supervisors of the Township of Washington, Franklin County, Pennsylvania pursuant to the authority as described above that Chapter 333, Article 1 of the Code of the Township of Washington, be amended as follows:

Section 1. Section 333-1, Speed limits established in the Code of the Township of Washington, shall be amended as follows:

<u>Road</u>	<u>From</u>	<u>To</u>	<u>Speed Limit</u>
1. Washington Township Blvd. T-429	PA Route 16	Station 2200	25 MPH
2. Washington Township Blvd. T-429	Station 2200	Old Forge Rd.	35 MPH
3. Washington Township Blvd. T-429	Old Forge Rd. SR 2007	Gehr Rd. T-384	35 MPH

Section 2. Stop signs shall be placed at the following street intersections:

<u>INTERSECTION</u>	<u>STOP SIGN PLACED ON</u>
1. Washington Township Boulevard T-429 and Old Rt. 16 SR 2010	Washington Township Boulevard
2. Old Forge Rd. SR 2007 and Washington Township Boulevard T-429	Washington Township Boulevard on both sides of Old Forge Rd.
3. Washington Township Boulevard T-429 and Country Club Rd. SR 2012	Country Club Road – both sides
4. Washington Township Boulevard T-429 and Buhrman Dr. East T-442	Buhrman Dr. East
5. Washington Township Boulevard T-429 and Honey Run Lane	Honey Run Lane
6. Washington Township Boulevard T-429 and Mystic Rock Lane North T-436	Mystic Rock Lane North
7. Washington Township Boulevard T-429 and Gehr Rd. T-384	Washington Township Boulevard

Section 3. This Ordinance shall be enforced in accordance with the provisions of the Vehicle Code of Pennsylvania as it pertains to fines and other penalties.


Section 4. Should any provision of this Ordinance be found unconstitutional or otherwise illegal or in any other manner unenforceable, the remaining sections of the Ordinance shall remain in full force and effect.

Section 5. This Ordinance shall become effective as provided by law.
