**ORDINANCE NO. 270**

**AN ORDINANCE SETTING THE SPEED LIMITS ON  
WASHINGTON TOWNSHIP BOULEVARD T-429 AND  
ESTABLISHING THE PLACEMENT OF STOP SIGNS  
WITH ALL INTERSECTING STREETS AND SKITTLE  
RUN COURT**

**WHEREAS**, an Ordinance establishing the speed limit on Washington Township Boulevard has not been ordained; and

**WHEREAS**, the Washington Township Board of Supervisors, in order to advance the welfare and safety of the residents of the Township and such other persons who use Washington Township Boulevard, deem it necessary to set speed limits on Washington Township Boulevard; and

**WHEREAS**, the Vehicle Code of Pennsylvania, Section 6109 provides for the establishing of speed limits on roads; and

**WHEREAS**, the Vehicle Code of Pennsylvania, Section 6109 provides for the placement of stop signs at intersecting streets; and

**WHEREAS**, the Board of Supervisors, retained the services of Grove Miller Engineering to complete a traffic study of Washington Township Boulevard for both the speed limit study and the placement of stop signs and Skittle Run Court for the placement of stop signs; and

**WHEREAS**, the completed traffic study concluded that the speed limit on Washington Township Boulevard between Gehr Road, (T-384) and Tomstown Road, (SR2015) should be 35 MPH and that stop signs should be placed at intersecting streets.

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED**, by the Board of Supervisors of the Township of Washington, Franklin County, Pennsylvania pursuant to the authority as described above that Chapter 333, Article 1 of the Code of the Township of Washington, be amended as follows:

Section 1. Section 333-1, Speed limits established in the Code of the Township of Washington, shall be amended as follows:

<u>Road</u>	<u>From</u>	<u>To</u>	<u>Speed Limit</u>
1. Washington Township Blvd. T-429	Gehr Rd. T-384	Tomstown Rd. SR2015	35 MPH

Section 2. Stop signs shall be placed at the following street intersections

**INTERSECTION**

- 1. Washington Township Boulevard T-429 and Tomstown Road SR2015
- 2. Washington Township Boulevard T-429 and Marshall Drive T-802
- 3. Washington Township Boulevard T-429 and Gehr Rd. T-384
- 4. Washington Township Boulevard T-429 and Mystic Rock Lane South T-436
- 5. Skittle Run Court  
And Honey Run Lane

**STOP SIGN PLACED ON**

- Washington Township Boulevard and Tomstown Rd. – both sides
- Marshall Drive T-802
- Washington Township Boulevard -both sides and Gehr Rd. – both sides
- Mystic Rock Lane South
- Skittle Run Court

Section 3. Should any provision of this Ordinance be found unconstitutional or otherwise illegal or in any other manner unenforceable, the remaining sections of the Ordinance shall remain in full force and effect.

Section 4. Should any provision of this Ordinance be found unconstitutional or otherwise illegal or in any other manner unenforceable, the remaining sections of the Ordinance shall remain in full force and effect.

Section 5. This Ordinance shall become effective five (5) days after adoption.
