ORDINANCE NO. 41

AN ORDINANCE

OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF WASHINGTON, FRANKLIN COUNTY, PENNSYLVANIA, TO ESTABLISH SPEED LIMITS ON CERTAIN STREETS AND ROADS WITHIN THE TOWNSHIP OF WASHINGTON, FRANKLIN COUNTY, PENNSYLVANIA, IN THE MANNER AND PROVIDED FOR IN THE ACT OF GENERAL ASSEMBLY OF 1959, APRIL 29, P.L. 58, § 1002, § 1103, ET SUPPLEMENTS AND AMENDMENTS:

WHEREAS, there are certain streets and roads within the limits of the Township of Washington, Franklin County, Pennsylvania, upon which no speed limits have been placed by proper authority; and

WHEREAS, the Board of Supervisors of the Township of Washington, Franklin County, Pennsylvania, in order to advance the public welfare of the residents of the Township of Washington, Franklin County, Pennsylvania, and such other persons who use said streets and roads, deem it necessary to enact speed limitations on certain streets and roads within the limits of the Township of Washington, Franklin County, Pennsylvania; and

WHEREAS, this Township shall establish said speed limitations in the manner and by the methods provided for in the Act of the General Assembly of 1959, April 29, P.L. 58, § 1002, § 1103, its supplements and amendments.

NOW THEREFORE, BE IT ENACTED AND ORDAINED, and it is enacted and ordained by the Board of Supervisors of this Township as follows:

Any person who shall operate a vehicle or tractor at a speed in excess of that hereby established therefor, upon any of the streets or portions thereof herein specified, shall, upon conviction thereof, be sentenced to pay a fine of Ten (10:00) dollars and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than Five (5) days.
