ORDINANCE NO. 82

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THIS TOWNSHIP,
AMENDING AND SUPPLEMENTING ORDINANCE NO. 41, ESTABLISHING
SPEED LIMITS ON CERTAIN STREETS AND ROADS WITHIN THE TOWNSHIP

WHEREAS, the Board of Supervisors on September 5, 1972, enacted Ordinance No. 41, establishing speed limits on certain streets and roads within the Township; and

WHEREAS, the Board of Supervisors finds that the following streets are within an "urban district" within the meaning of the Vehicle Code of 1976:

Charmian Road (TR 701) from Buchanan Trail East (Pa. Rt. 16) to the Adams County line

Airport Road (TR 369) from Midvale Road (LR28024) to Pen Mar Road (LR 28026)

Pennersville Road (TR 378) from Fort Ritchie Access Road (LR 1047) to Old Route 16 (LR 28068)

Norwood Avenue (TR 372) from Monterey Lane (LR 28027) to Orchard Ave. (TR 372)

Orchard Avenue (TR 377) from Monterey Lane (LR 28027) to Jacob's Church Road (TR 377); and

WHEREAS, the Board of Supervisors, under the authority of ss6109 and ss3362 of the Vehicle Code desires to establish a maximum speed limit of 35 miles per hour on said Charmian Road, Airport Road and Pennersville Road; and, upon the basis of an engineering and traffic investigation performed under the authority of ss3363 of the Vehicle Code, maximum speed limit of 25 miles per hour on said Norwood Avenue and Orchard Avenue.

NOW THEREFORE, BE IT ENACTED AND ORDAINED, and it is enacted and ordained, by the Board of Supervisors of this Township, as follows:

SECTION 1: Ordinance No. 41 is amended to establish the following maximum speed limits:

Charmian Road (TR701)	Pa. Rt. 16 and Adams Co. line	35
Airport Road (TR 369)	LR 28024 and LR 28026	35
Pennersville Rd. (TR378)	LR1047 and LR 28068	35
Norwood Avenue (TR 668)	LR 28027 and TR 372	25
Orchard Avenue (TR 372)	LR 28027 and TR 377	25

SECTION 2: The provisions of this Ordinance shall be enforceable in accordance with the provisions of said Ordinance No. 41.

SECTION 3. All other provisions of said Ordinance No. 41 shall remain in full force and effect.

SECTION 4. This Ordinance shall take effect five (5) days from the enactment hereof.
