

ORDINANCE NO. 130

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF WASHINGTON TOWNSHIP, FRANKLIN COUNTY, PENNSYLVANIA, ADDING LANDS TO THE AGRICULTURAL SECURITY AREA WITHIN THE TOWNSHIP, THEREBY CREATING A REVISED AGRICULTURAL SECURITY AREA FOLLOWING THAT FIRST ESTABLISHED IN 1983, IN ACCORDANCE WITH THE PROVISIONS OF THE AGRICULTURAL AREA SECURITY LAW, ACT OF JUNE 30, 1981, P.L. 128, NO. 43, AS AMENDED.

WHEREAS, the Board of Supervisors of this Township on December 5, 1983, by adopting Ordinance No. 85, created the first Agricultural Security Area within Washington Township; and

WHEREAS, the Agricultural Area Security Law requires Washington Township Supervisors to review the established agricultural security area each seven years; and

WHEREAS, the Board of Supervisors has conducted such seven-year review and, as a result thereof, adopted Ordinance No. 120 on January 7, 1991; and

WHEREAS, certain landowners have proposed the addition of land to the Agricultural Security Area, which addition may occur at any time; and

WHEREAS, the proposal for such additions have followed all of the procedures and requirements of Sections 5, 6, 7 and 8 of the Agricultural Area Security Law, the Act of June 30, 1981, P.L. 128, No. 43, as amended; and

WHEREAS, the proposed additions have been reviewed by the Township Planning Commission and the Township Agricultural Security Area Advisory Committee, and the Board of Supervisors has received the recommendations of the Planning Commission and the Committee, and

WHEREAS, the Board of Supervisors conducted a public hearing on said proposed additions on Monday, November 21, 1994; and

WHEREAS, the Board of Supervisors believes it is in the best interests and general welfare of the residents of this Township to add certain agricultural lands to the Agricultural Security Area within the Township.

NOW, THEREFORE, BE IT ORDAINED, and it is ordained by the Board of Supervisors of this Township, in accordance with the provisions of the Agricultural Area Security Law, the Act of June 30, 1981, P.L. 128, No. 43, as amended, as follows:

Section 1. There is hereby established in Washington Township, Franklin County, Pennsylvania, a revised Agricultural Security Area comprising those lands shown on the map attached hereto and made a part of this Ordinance, which shall hereafter be referred to as the Washington Township Agricultural Security Area Map.

Section 2. From the effective date of this Ordinance, those lands comprising said Agricultural Security Area shall be subject to the provisions of the Agricultural Area Security Law, the Act of June 30, 1981, P.L. 128, No. 43, as amended.


Section 3. Ordinance No. 120, adopted January 7, 1991, is repealed in its entirety.


Section 4. This Ordinance shall become effective five days after its adoption.


