## **ORDINANCE NO. 227**

AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON AMENDING THE CODE OF THE TOWNSHIP OF WASHINGTON TO PROVIDE FOR THE ADOPTION INTO THE CODE OF THE TOWNSHIP'S "POLICE PENSION PLAN" AND "NONUNIFORMED EMPLOYEES' PENSION PLAN" BY REFERENCE.

WHEREAS, the Township of Washington (hereinafter "Township") has adopted a "Police Pension Plan" and "Nonuniformed Employees' Pension Plan"; and

WHEREAS, Township enacted a Codification Ordinance for all of the Township Ordinances; and

WHEREAS, at the time of the Codification, the Township attempted to adopt the "Police Pension Plan" and "Nonuniformed Employees' Pension Plan" by reference; and

WHEREAS, the Township may not have properly adopted by reference the "Police Pension Plan" and "Nonuniformed Employees' Pension Plan" at the time the Township Ordinances were codified; and

WHEREAS, the Township desires to affirm its' adoption of the "Police Pension Plan" and "Nonuniformed Employees' Pension Plan" by reference.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED,** by the Board of Supervisors of the Township of Washington, Franklin County, Pennsylvania, by authority of the same as follows:

Section 1. - Section 56-1 of Article I of Chapter 56 of the Code of the Township of Washington, (hereinafter "Code") is amended to read as follows:

"§ 56-1 Adoption by Reference.

The original Ordinance adopting the Township of Washington "Police Pension Plan" and any amendments to said Ordinance are hereby adopted by Reference."

Section 2. - Section 56-2 of Article II of Chapter 56 of the Code is amended to read as follows:

"§ 56-2 Adoption by Reference.

The original Ordinance adopting the Township of Washington "Nonuniformed Employees' Pension Plan" and any amendments to said Ordinance are hereby adopted by reference."

Section 3. - <u>SEVERABILITY</u>. The provisions of this Ordinance are severable. If any section, paragraph, sentence, or clause hereof shall be declared illegal, unconstitutional or invalid by any court of competent jurisdiction, such illegality, unconstitutionality or invalidity shall not affect the remaining portions of this Ordinance and it hereby is declared the intention and purpose of the Board of Supervisors that this Ordinance would have been enacted without such illegal, unconstitutional or invalid provision.

Section 4. - <u>REPEALER</u>. All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance hereby are repealed in so far, but only insofar, as the same are inconsistent herewith.

Section 5. - <u>EFFECTIVE DATE</u>. This Ordinance shall take effective in accordance with law.
