WHEREAS, the Board of Supervisors of Washington Township having received a request from <u>Jack and Emily Martin</u> indicating their desire to have their properties located at <u>4469 Salem Church Road, Tax Parcel # Q10-017, comprising 90 acres</u> and another on <u>5295 Polktown Road, Tax Parcel # Q11-001, comprising 107.67 acres</u>; and <u>Benjamin and Kelsey Barnett</u> indicating their desire to have their property on <u>Marsh Road, Tax Parcel # Q16-006, comprising 13 acres</u> be added to the Agricultural Security Area.

Section 1. The Board of Supervisors declares and accepts the addition of these parcels to the Agricultural Security Area for Washington Township.
