RESOLUTION #794

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THIS TOWNSHIP REVISING THE PROCEDURE FOR THE SALE OF SURPLUS PERSONAL PROPERTY OF AN ESTIMATED SALE VALUE OF LESS THAN TWO THOUSAND DOLLARS

WHEREAS, Section 1504 of the Second Class Township Code, 63 P.S. 66504, provides that the Board of Supervisors may dispose of surplus personal property having an estimated fair market value less than two thousand dollars without advertisement for bids or public auction upon the adoption a resolution of a procedure for the sale of such surplus personal property; and

WHEREAS, the Board of Supervisors desire to update the procedures for the sale of such property.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors as follows:

- 1. Resolution 90 of Washington Township and all other previous resolutions for the sale of surplus personal property by the Township are revoked and superseded.
- 2. Whenever the Township shall be in possession of surplus personal property having an estimated value of less than two thousand dollars, the Board of Supervisors has the authority to declare such property surplus at a public meeting, thereby authorizing the Township Manager to sell the property at a price acceptable to the Manager as its fair market value to anyone offering to purchase it. Such sales shall be reported to the Board.
- 3. In disposing of such surplus property, the Township Manager, in his discretion, may consider donating or selling the property at a reduced rate to:
 - a. Other government entities
 - b. Volunteer fire companies, ambulance services, or rescue squads
 - c. Nonprofit public libraries
- d. Nonprofit corporations engaged in community industrial, commercial or affordable housing development
 - e. Nonprofit housing corporations
 - f. Nonprofit organizations providing community service or development activities
- g. Nonprofit corporations established for the preservation of historical architectural or aesthetical sites or artifacts
 - h. Nonprofit medical service corporations
- 4. When declaring personal property having an estimated value of less than two thousand dollars belonging to the Washington Township Police Department to be surplus, the Board of Supervisors may direct the Chief of Police, rather than the Township Manager, to take responsibility for the sale or donation of the property pursuant to the above procedures.
