RESOLUTION No. 381

**OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP
OF WASHINGTON, FRANKLIN COUNTY, PENNSYLVANIA,
ESTABLISHING RULES AND REGULATIONS FOR
ADMINISTERING A PROCEDURE FOR THE CURBSIDE
COLLECTION OF LEAF AND YARD WASTE PURSUANT
TO ORDINANCE #187.**

WHEREAS Ordinance #187 provide for the curbside collection of leaf, tree trimming and brush; and

WHEREAS Section 4 of Ordinance #187 provides that the Board of Supervisors may by resolution establish leaf, tree trimming, and brush curbside pickup programs; and

WHEREAS the Board of Supervisors desire to establish rules and regulations governing these curbside pickup programs.

NOW, THEREFORE, the Board of Supervisors of the Township of Washington does hereby resolve as follows:

ARTICLE 1. CURBSIDE LEAF COLLECTION PICKUP PROGRAM

SECTION 1. COLLECTION PRACTICES

1. During the months of October and November of each year the Township will provide curbside pickup of leaf waste.
2. A schedule will be published by the Township with the dates of collection in each region of the Township.
3. Residents shall use biodegradable/compostable bags for leaf waste pickup.
4. Leaf waste shall be separated from other waste, bagged in the appropriate bag, tied, and placed at the edge of the nearest roadway for pickup.
5. Biodegradable/compostable bags may be obtained at the Township office or Transfer Station for a fee, or home supply stores.

- 6. Nothing in these regulations shall keep individuals from composting leaf waste on their property or hauling the leaf waste to a proper composting facility.

ARTICLE 2. CURBSIDE TREE TRIMMING AND BRUSH PICKUP PROGRAM


SECTION 1. COLLECTION PRACTICES

- 1. Haulers that provide residential service to customers in Washington Township shall provide twice a year curbside tree trimming and brush pickup programs.
- 2. The third (3rd) week of May and the third (3rd) week of October shall be set as the date for pickup.
- 3. Hauler shall provide a schedule with the days of the week they will collect in each region of the Township and any fees for this service. The Township shall not pay for this service.
- 4. Preparation of tree trimmings and brush
 - a. Tree trimmings shall have a maximum diameter of four (4") inches and shall be cut no greater than four (4') foot lengths for easy loading.
 - b. Tree trimmings and brush shall be tied in secure bundles and placed at the edge of the nearest roadway for pickup.
- 5. Nothing in these regulations shall keep individuals from composting tree trimmings and brush on their property or hauling the tree trimmings and brush to a proper composting facility.


