**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THIS
TOWNSHIP ACCEPTING FOR DEDICATION CERTAIN LANDS
OFFERED FOR USE AS ROADWAYS IN THE TOWNSHIP.**

WHEREAS, certain final subdivision plans have heretofore been submitted to the Supervisors of Washington Township, Franklin County, Pennsylvania, in accordance with the provisions of Ordinance No. 161, known as the Washington Township Subdivision and Land Development Ordinance, adopted October 21, 2002; and

WHEREAS, the owners and developers of said subdivisions have offered to the Township for dedication as public ways the streets respectively shown therein and to the extent that said streets have been completed in accordance with the provisions of Ordinance No. 161; and

WHEREAS, the Township has determined that said streets listed in the table attached hereto have met all the requirements with respect to construction thereof as set forth in Ordinance No. 161; and

WHEREAS, the Township, pursuant to the provisions of Ordinance No. 161, desire to formally record its acceptance of said streets for public road purposes.


