Section 1. The Board of Supervisors declare and accept the Agricultural Security map dated June 2nd, 2009 as the Agricultural Security Area for Washington Township.

Section 2. The attached Exhibit "A" shall be recorded in the Office of the Recorder of Deeds, Franklin County, Pennsylvania.

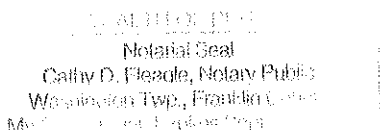

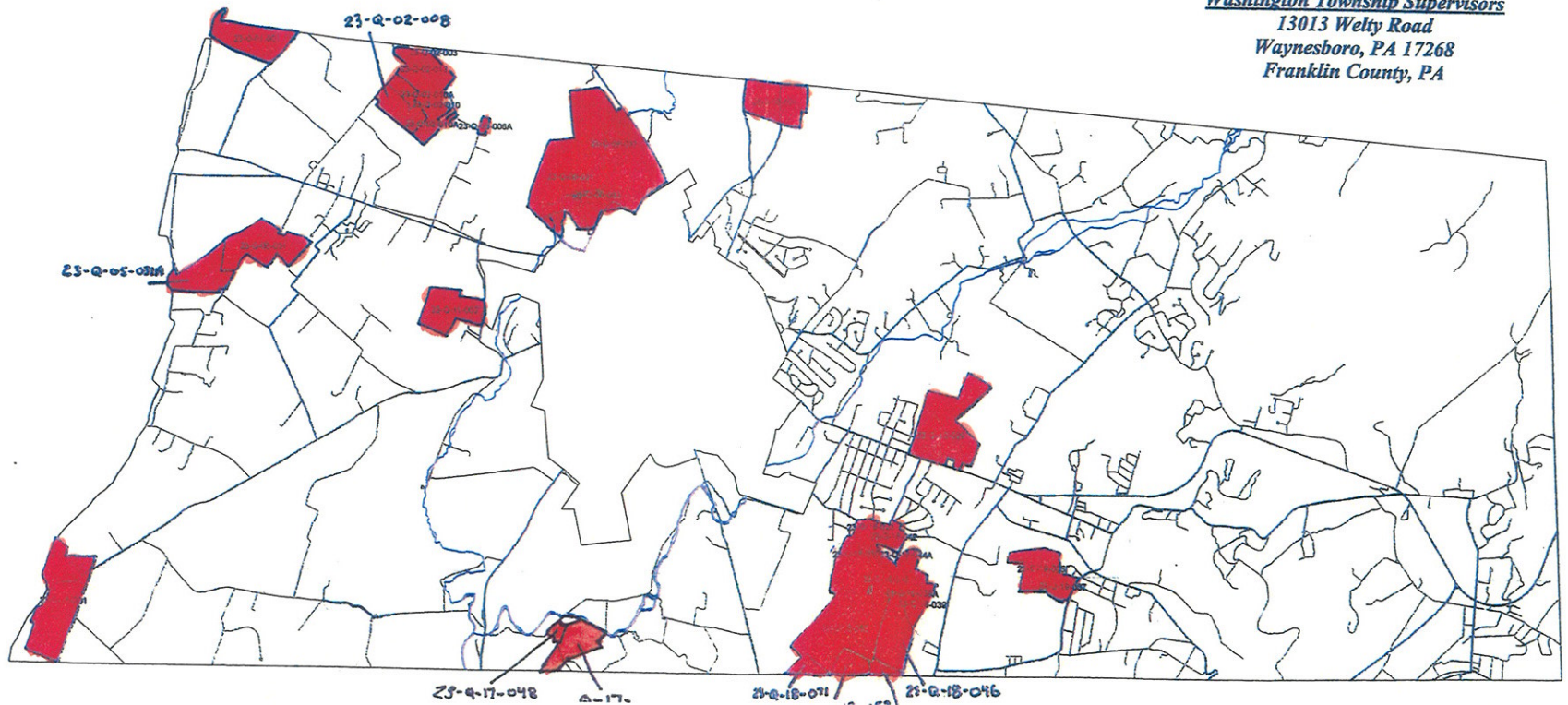
