ACKNOWLEDGING THE YEARS OF SERVICE TO THE TOWNSHIP BY

WHEREAS, **Fred L. Eisenhart** served as a member of the Washington Township Municipal Authority from 1990 to 1995 and from 2001 to 2017; and

WHEREAS, during these twenty-two years of service the Municipal Authority owned and operated sewer system was expanded to meet the needs of this Township, reached its capacity due to growth made possible by sewer and finally was upgraded to meet the future needs of the Township into the 21st century; and

WHEREAS, during this same period the public water and sewer systems was upgraded and expanded many times to meet the future needs of the Township including construction of a water tank at Pine Hill, a twelve inch water main along the current and future Washington Township Boulevard from Rouzerville to Rt. 997, four new wells, replacement of more than five miles Wastewater Conveyance System Trunk Line, construction of fifty four hundred lineal feet of eight inch Force Main and a new Pump Station in Blue Ridge Summit and the construction of a new Authority's Office Building; and

WHEREAS, **Fred Eisenhart** has played an integral part in these upgrades and expansion by providing leadership and insight as the as chairman of the Board from January 2009 until December 2017; and

WHEREAS, the Washington Township Board of Supervisors desires to recognize **Fred Eisenhart** for these many years of dedicated service with the Washington Township Municipal Authority.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of this Township that **Fred Eisenhart** is hereby recognized for his many years of dedicated service to the Washington Township Municipal Authority and to the Washington Township Community.

AND BE IT FURTHER RESOLVED that a certified copy of this Resolution be presented to **Fred Eisenhart** as further expression of appreciation of the Board of Supervisors.
