**OF THE BOARD OF SUPERVISORS OF THIS TOWNSHIP  
AMENDING THE EQUIPMENT RATES FOR THE USE OF  
TOWNSHIP EQUIPMENT.**

**WHEREAS**, at the township's reorganizational meeting each year the Washington Township Board of Supervisors established an equipment rate for the use of township equipment; and

**WHEREAS**, from time to time new equipment is added to the township equipment fleet; and

**WHEREAS**, from time to time the township rate for use of our equipment needs revised to match market rates; and

**WHEREAS**, the township supervisors would like to amend the equipment rate to include new equipment purchases by the township and rate changes to existing equipment as listed below.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Supervisors of this Township, as follows:

The previous equipment rental rate as established by the Board of Supervisors is hereby rescinded by this resolution.


## **Section 3. Effective Dates**
