**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THIS
TOWNSHIP ACCEPTING FOR DEDICATION CERTAIN LANDS
OFFERED FOR USE AS ROADWAYS IN THE TOWNSHIP.**

WHEREAS, certain final subdivision plans have heretofore been submitted to the Supervisors of Washington Township, Franklin County, Pennsylvania, in accordance with the provisions of the Code of the Township of Washington, Chapter 310, adopted November 23, 2009 as amended; and

WHEREAS, the owners and developers of said subdivisions have offered to the Township for dedication as public ways the streets respectively shown therein and to the extent that said streets have been completed in accordance with the provisions of the Code of the Township of Washington, Chapter 310; and

WHEREAS, the Township has determined that said streets listed in the table attached hereto have or will meet all the requirements with respect to construction thereof as set forth in the Code of the Township of Washington, Chapter 310; and




