

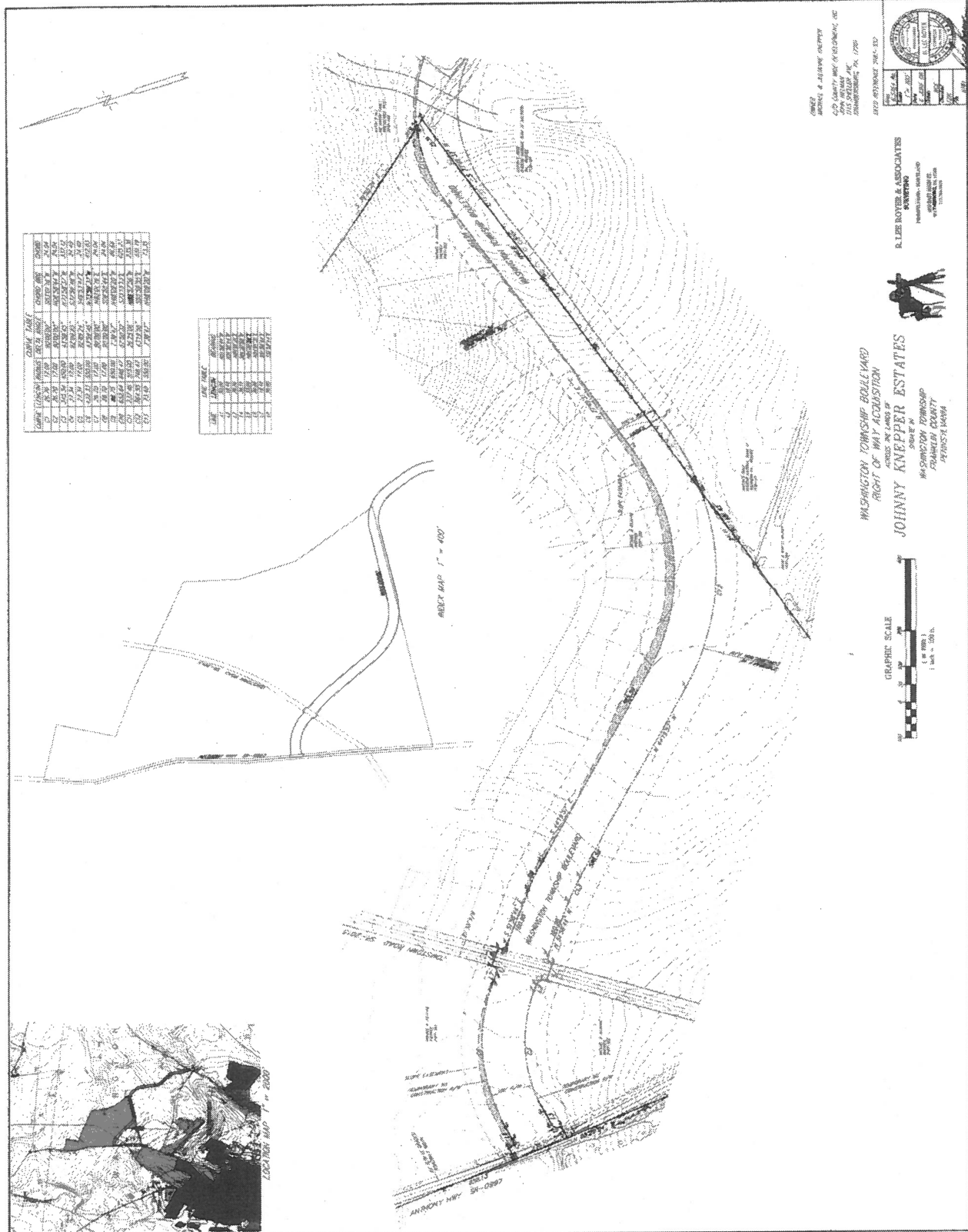

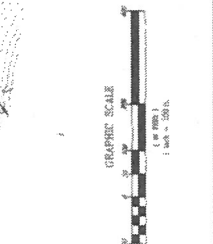


Exhibit "A" to Deed
