ORDINANCE NO. I

An Ordinance ordaining, laying out and opening certain streets in Eastland Hills, Washington Township, to-wit: Eastland Road, Summit Avenue, Mickley Avenue, Mountain View Road, Eastmount Place, and Eastland Circle.

BE IT ORDAINED AND ENACTED by the Supervisors of Washington Township, Franklin County, Pennsylvania, and it is hereby ordained and enacted by authority of the same:

Section 1. That a certain street named Eastland Road be and the same is hereby ordained, laid out and opened on a course, the center line of which begins at a point on the East curbline of North East Avenue, opposite Station 4489.6 as shown on plans approved May 16, 1946 by the Town Council of the Borough of Waynesboro; thence South 57 degrees 55 minutes East 320.0 feet to the center of Eastmount Place; thence South 57 degrees 55 minutes East 73.0 feet to the center of Summit Avenue; thence on the arc of a curve to the left having a radius of 203.44 feet, 126.64 feet to a point; themse on the arc of a curve to the right having a radius of 312.0 feet, 357.58 feet to a point; thence on the arc of a curve to the left having a radius of 410.0 feet, 163.99 feet to the center of Mickley Avenue; thence continuing on the aforesaid arc, 446.41 feet to a point; thence on the arc of a curve to the right having a radius of 175.0 feet, 23.67 feet to the center of Mountain View Road; thence continuing on the aforesaid arc, 382.20 feet to a point; thence on the arc of a curve to the right having a radius of 350.0 feet, 148.13 feet to a point on the centers of Eastland Circle and Summit Avenue, the end of Eastland Road, said street having a total length of 2041.62 feet and being 24 feet in width, all of which shall be used as a roadway.

Section 2. That a certain street named Summit Avenue be and the same is hereby ordained, laid out and opened on a course, the center line of which begins at a point on the center of Eastland Road, 73.00 feet Eastwardly from the center of Eastmount Place; thence South 57 degrees 55 minutes East 2.34 feet to a point; thence on the arc of a curve to the right having a radius of 233.62 feet, 225.21 feet to a point; thence on the arc of a curve to the left having a radius of 334.0 feet, 280.69 feet to a point; thence South 50 degrees 45 minutes East, 140.00 feet to the center of Mickley Avenue; thence South 50 degrees 45 minutes East 353.00 feet to a point; thence on the arc of a curve to the left having a radius of 350.0 feet, 520.15 feet to the centers of Eastland Road and Eastland Circle, the end of Summit Avenue, said street having a total length of 1521.39 feet and being 24 feet in width, all of which shall be used as a roadway.

Section 3. That a certain street named Mickley Avenue be and the same is hereby ordained, laid out and opened on a course, the center line of which begins at a point on the North right-of-way line of Pennsylvania State Highway Legislative Route 44, opposite Station 164:16; thence North 39 degrees 15 minutes East 237.0 feet to the center of Summit Avenue; thence North 39 degrees 15 minutes East 270.0 feet to the center of Eastland Road, the end of Mickley Avenue, said street having a total length of 507.0 feet and being 30 feet in width, all of which shall be used as a roadway.

Section 4. That a certain street named Mountain View Road be and the same is hereby ordained, laid out and opened on a course, the center line of which begins at a point on the East curbline of North East Avenue, opposite station 9.79.6 as shown on the plans approved May 16, 1946 by the Town Council of the Borough of Waynesboro; thence South 57 degrees 55 minutes East 182.12 feet to a point; thence South 46 degrees 38 minutes East 158.44 feet to the center of Eastmount Place; thence South 46 degrees 38 minutes East 956.42 feet to a point; thence on the arc of a curve to the right having a radius of 300.0 feet, 161.27 feet to the center of Eastland Road, the end of Mountain View Road, said street having a total length of 1458.25 feet and being 24 feet in width, all of which shall be used as a roadway.

Section 5. That a certain street named Eastmount Place be and the same is hereby ordained, laid out and opened on a course, the center line of which begins at a point on the center line of Eastland Road, 337.5 feet Eastwardly from the center of North East Avenue; thence North 32 degrees 05 minutes East 459.0 feet to the center of Mountain View Road, the end of Eastmount Place, said street having a total length of 459.0 feet and being 24 feet in width, all of which shall be used as a roadway.

Section 6. That a certain street named Eastland Circle be and the same is hereby ordained, laid out and opened on a course, the center line of which begins on the North right-of-way line of Pennsylvania State Highway Legislative Route யி, opposite Station 173+91.46; thence North 48 degrees 50 minutes East 7.85 feet to a point; thence on the arc of a curve to the left having a radius of 200.0 feet, 223.52 feet to a point; thence North 15 degrees 12 minutes West 1795 feet to a point opposite the end of Eastland Circle; thence North 15 degrees 12 minutes West 32.12 feet to a point; thence on the arc of a curve to the right having a radius of 560.0 feet, 391.44 feet to a point; thence on the arc of a curve to the right having a radius of 390.0 feet, 60.80 feet to a point on the centers of Summit Avenue and Eastland Road; thence on the arc of a curve to the right having a radius of 390.0 feet, 100.74 feet to a point; thence on the arc of a curve to the right having a radius of 130.0 feet, 300.70 feet to a point; thence on the arc of a curve to the right having a radius of 390.0 feet, 161.54 feet to a point; thence on the arc of a curve to the right having a radius of 560.0 feet, 391.44 feet to a point; thence South 64 degrees 54 minutes West 20.0 feet to a point, the end of Eastland Circle, said street having a total length of 1708.10 feet and being 24 feet in width, all of which shall be used as a roadway.

Section 7. There is adopted as a part of this Ordinance a plan and map of the foregoing streets showing the location thereof as prepared by Bernard F. Smith, P.E.

Section 8. All of said streets shall hereafter be and become a part of the public road system of Washington Township.

Ordained and enacted into an Ordinance this 3rd day of February, 1951.
