Washington Township Ordinance No. 35

An Ordinance granting permission to erect poles and to erect, maintain and attach wires, aerial cables and associated appliances in connection with a proposed wired television system to such poles and to existing utility poles within Washington Township, Franklin County, Pennsylvania, subject insofar as existing utility poles are concerned, to the consent of the utility companies owning such poles, and for the traversing and crossing of such wires, aerial cables and associated appliances above streets, alleys and roads in the Township; and imposing conditions and providing for bond.

WHEREAS, application has been made by TeleCable Communications Corporation, with offices at Baltimore, Maryland, for itself and its assigns for permission to erect poles and to erect, maintain and attach wires, aerial cables and associated appliances in connection with a proposes wired television system to such poles and to existing utility poles within the Township of Washington, Franklin County, Pennsylvania, and for the traversing and crossing of such wires, aerial cables and associated appliances above streets, alleys and roads in the said Township.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Supervisors of Washington Township, Franklin County, and it is hereby ordained and enacted by authority of the same: SECTION 1. That permission be granted to TeleCable

Communications Corporation, and its assigns, to erect poles and to

traverse and cross above streets, alleys and roads along such

poles and the presently existing public utility pole lines within

the said Township of Washington with wires, aerial cables and

associated appliances in connection with a proposed wired tele
vision system, and, insofar as existing utility poles are con
cerned, upon receiving consent from the utility companies whose

poles are to be used, to attach such wires, aerial cables and

associated appliances to such poles of utility companies as are

now erected or replacements thereof, and to erect poles and to

operate and maintain such wires, aerial cables and associated

appliances.

SECTION 2. That the poles, wires, aerial cables and associated appliances hereby permitted shall at all times be maintained in good safe condition.

SECTION 3. That prior to the erection of the said poles, wires, aerial cables and associated appliances, there shall be filed with the Township Secretary, a public liability bond in the amount of Five Thousand (\$5000.00) Dollars and a property damage bond in the amount of One Thousand (\$1000.00) Dollars, or one bond combining both coverages, with good corporate surety, conditioned to fully and completely indemnify and save harmless the Township of Washington from all actions, claims, suits and demands of whatsoever kind, and against all damages of whatsoever

kind arising from or in any way incident to the erection, maintenance and operation of the said poles, wires, aerial cables and associated appliances.

SECTION 4. EFFECTIVE DATE. This Ordinance shall become effective March 5, 1971.
