ORDINANCE NO. 106

AN ORDINANCE ESTABLISHING SPEED LIMITS
ON CERTAIN STREETS AND ROADS WITHIN
WASHINGTON TOWNSHIP.

WHEREAS, there are certain streets and roads within Washington Township upon which no speed limits have been established; and

WHEREAS, the Washington Township Board of Supervisors, in order to advance the welfare and safety of the residents of the Township and such other persons who use said streets and roads, deems it necessary to enact speed limitations on certain streets and roads in Washington Township; and

WHEREAS, the Vehicle Code of Pennsylvania, Section 6109, provides for the establishing of speed limits on streets and roads; and

WHEREAS, Section 3362 of the Vehicle Code provides for the establishment of a maximum speed of 35 mph in any urban district; and

WHEREAS, Section 3363 of the Vehicle Code provides for the establishment of lower maximum speeds upon the basis of an engineering and traffic investigation; and

WHEREAS, the Board of Supervisors, after completing studies of the following streets and roads, finds them to be either within an "urban district" as per the Vehicle Code of Pennsylvania or otherwise in need of speed limitations.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, and it is enacted and ordained, by the Board of Supervisors of this Township, as follows:

Section 1. The maximum speed limit for the following streets and roads is hereby established as follows:

1. Old Forge Road T392	Mentzer Gap Road T378 and Quincy Township Line	35
2. Mentzer Gap Road T378	Old Forge Road T392 and Beartown Road T702	35

3.	Mentzer Gap Road T378	Beartown Road T702 and Boundary of State Forest Land	25
4.	Mentzer Gap Road T378	Boundary of State Forest Land to PA Route 16	35
5.	Old Pen Mar Road T357	Harbaugh Church Road SR2009 to Pen Mar Road SR2008	35
6.	Blue Ridge Avenue T398	Wyndham T379 to Maryland State Line	35
7.	Fish & Game Road T375	Mentzer Gap Road SR2007 to Quincy Township Line	35
8.	Furnace Road T382	Charmian Road T701 to Adams County Line	25
9.	North Landis Avenue T408	PA Route 16 to dead end	25
10.	Strickler Avenue T406	PA Route 16 to Amsterdam Road T329	25

Section 2. This Ordinance shall be enforced in accordance with the provisions of the Vehicle Code of Pennsylvania as it pertains to fines and other penalties.

Section 3. Section 2 of Washington Township Ordinance No. 82, enacted September 19, 1983, is hereby repealed; the following language of Washington Township Ordinance No. 41, enacted September 5, 1972, is hereby repealed:

"Any person who shall operate a vehicle or tractor at a speed in excess of that hereby established therefor, upon any of the streets or portions thereof herein specified, shall, upon conviction thereof, be sentenced to pay a fine of Ten (10.00) dollars and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than five (5) days."


Section 4. Should any provision of this Ordinance be found unconstitutional or otherwise illegal or in any other manner unenforceable, the remaining sections of the Ordinance shall remain in full force and effect.

Section 5. This Ordinance shall take effect five (5) days after enactment thereof.


