## ORDINANCE NO. 127

## AN ORDINANCE

OF THE BOARD OF SUPERVISORS OF WASHINGTON TOWNSHIP, FRANKLIN COUNTY, PENNSYLVANIA, BY AUTHORITY OF AN PURSUANT TO THE PROVISIONS OF ARTICLES VI THROUGH X OF ACT NO. 247, AS AMENDED, OF THE GENERAL ASSEMBLY OF THE COMMONWEALTH OF PENNSYLVANIA, APPROVED JULY 31, 1968, KNOWN AS CITED AS THE "PENNSYLVANIA MUNICIPALITIES PLANNING CODE"; AND ANY AMENDMENTS AND SUPPLEMENTS THERETO, AMENDING ORDINANCE NO. 105, ADOPTED BY THE BOARD OF SUPERVISORS OF WASHINGTON TOWNSHIP ON MAY 16, 1988, AND KNOWN AS THE WASHINGTON TOWNSHIP ZONING ORDINANCE.

WHEREAS, the Board of Supervisors of Washington Township, Franklin County, Pennsylvania, adopted on May 16, 1988, Washington Township Ordinance No. 105, known as the Washington Township Zoning Ordinance; and

WHEREAS, the Board of Supervisors of Washington Township deems it to be in the interest and welfare of the residents of the Township to amend the Washington Township Zoning Ordinance by altering the Washington Township Zoning Map as described below and as shown on the annexed map.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, and it is hereby enacted and ordained by the Board of Supervisors of Washington Township, Franklin County, Pennsylvania, that the Zoning Map of the Township adopted pursuant to Ordinance No. 105, known as the Washington Township Zoning Ordinance, be revised and Ordinance No. 105 is hereby amended as follows:

**SECTION 1.** A 37.47 acre parcel owned by J. Fred Martin located just north of Stottlemyer Road, as more fully described herein, and as set forth on the Zoning Map shall be rezoned from Agricultural (A) to Low Density Residential (R-1).

BEGINNING at an iron pin on the southwest corner of the tract at lands of Paul A. Blubaugh; thence with lands of Blubaugh north 31 degrees 07 minutes 50 seconds east 517.25 feet to an iron pin; thence continuing with lands of Blubaugh north 47 degrees 46 minutes 44 seconds west 72.99 feet to an iron pin; thence with lands of Blubaugh north 40 degrees 27 minutes 54 seconds east 289.25 feet to an iron pin; thence with lands of Blubaugh north

54 degrees 34 minutes 30 seconds west 874.57 feet to an iron pin; thence along lands of John Knepper north 77 degrees 03 minutes 30 seconds east 1481.30 feet to an iron pin; thence with other lands of J. Fred Martin and lands of Leroy J. Martin south 40 degrees 07 minutes 32 seconds east 418.38 feet to an iron pin; thence along lands of John H. Gallagher south 21 degrees 53 minutes 39 seconds west 902.30 feet to an iron pin; thence along lands of Gallagher south 39 degrees 31 minutes 40 seconds west 571.59 feet to an iron pin and post; thence along lands of Gallagher south 33 degrees 47 minutes 32 seconds west 390 feet, more or less, to the existing R-1 zoning line; thence along this zoning line approximately 625 feet to an iron pin, the place of beginning.

SECTION 2. In all other respects, the provisions of Ordinance No. 105, as amended, and the Washington Township Zoning Map, as amended, shall remain in full force and effect.

This ordinance shall take effect five days after its SECTION 3. enactment.
