

Resolution Accepting Dedication  
of Street by Deed

WHEREAS, The Church of the Apostles, United Church of Christ, Waynesboro, Franklin County, Pennsylvania, a non-profit corporation, has tendered to the Township of Washington, a municipal corporation of Franklin County, Pennsylvania, a deed dated April 16, 1968 conveying to the Township of Washington a strip of land 50 foot in width and 884.17 feet in length extending from the southerly terminus of Barnett Avenue in the Village of Wayne Heights, Washington Township, Franklin County, Pennsylvania, as now ordained, southwardly to Washington Township Road No. 365 sometimes known as the Abattoir Road, and

WHEREAS, The Township of Washington finds it to be in the public interest that Barnett Avenue be extended as a public road on the course described in the aforesaid deed,

NOW, THEREFORE, BE IT RESOLVED THAT the Supervisors of Washington Township, Franklin County, Pennsylvania, in meeting assembled to hereby accept the proffered deed from the Church of the Apostles, United Church of Christ, of Waynesboro, Franklin County, Pennsylvania, for a parcel of land 50 feet in width to be used for public road purposes and described in said deed as follows:

ALL the following real estate lying and being situate in Washington Township, Franklin County, Pennsylvania, bounded and described as follows:

BEGINNING at a point at the intersection of the centerline of Barnett Avenue and the property line on the southern border of Wayne Heights, thence along the centerline of Barnett Avenue South 25 degrees 39 minutes West 77.22 feet to the P.C. of a curve; thence along the arc of a curve to the right having a radius of 415 feet an arc distance of 155.72 feet to the P.T. of the curve; thence South 47 degrees 09 minutes West 62.88 feet to the P.C. of a curve; thence along the arc of a curve to the left having a radius of 338 feet an arc distance of 148.36 feet to the P.T. of the curve; thence South 22 degrees 00 minutes West 43.44 feet to the P.C. of a curve; thence along the arc of a curve to the right having a radius of 302 feet an arc distance of 164.27 feet to the P.T. of the curve; thence South 53 degrees 10 minutes West 232.28 feet to a point on the South property line of the lands of the Church of the Apostles and located in Abbatoir Road. Being the center line of a 50 foot parcel of land extending 25 feet on each side of said line. Said real estate is bounded on the North by Barnett Avenue, on the South by Abattoir Road, on the East and West by lands of the Church of the Apostles.
