Waiver and Release of Liability

Please Read Carefully

In consideration of furnishing a skatepark to enable me to participate in skateboarding or in line skating, I agree as follows:

I fully understand and acknowledge that: (A) risks and dangers exist in my use of skatepark equipment and skateboarding or in line skating; (B) my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability; (C) these risks and dangers may be caused by the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes, These risks and dangers may arise from foreseeable or unforeseeable causes; and (D) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the supervisors, public officials, officers, employees of Washington Township or by any other person.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Washington Township and its supervisors, public officials, officers, and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of the skatepark or my participation in skateboarding or in line skating. I understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the supervisors, public officials, officers, or employees of Washington Township. This waiver is kept on file and valid indefinitely and is in effect whenever I'm at the skatepark in the Pine Hill Regional Recreation Area.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE WASHINGTON TOWNSHIP FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.
